



**CITY OF ROYAL CITY
COUNCIL MINUTES
December 16, 2025**

The City Council of the City of Royal City, Grant County, Washington, met in regular session on December 16, 2025. The meeting was called to order at 7:00 pm by Mayor Piercy.

MEMBERS PRESENT: Mayor Piercy, Councilmembers Fanning, Garcia, Rodriguez and Kannely. **A motion was made to excuse Councilmember Christensen. (m/s Fanning/Garcia), the motion carried.**

PRESENTATIONS

- Bob Murphy with Royal Golf Association discussed the need for additional funding for the Royal Golf Course and the previous approval of \$20,000.00 for the purchase of a mower. The course is always improving, play is up and there is always a need for updated equipment. They always buy used equipment and finance it. The previous request for \$30,000 is to cover general expenses and keep the doors open as a community service. Seasonal employees are laid off as soon as possible. They currently have a balance of \$12,000.00, which will not sustain them until spring. There was Council discussion, which included rates charged for the RV spots, Royal Port District paying for their sign at the course, School District contributions as the course is used by the golf team, and details about fundraising events and the use/promotion of the Community Center.
